Based on discussions with Model N customers, this pay-and-chase process typically only results in a 10 to 20% recovery after a prolonged settlement process.



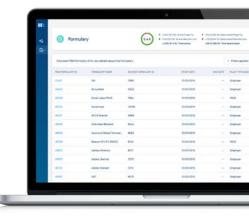
